The author(s) warrant(s) that the article, monograph or publication is the author's (s') original work, has not been published before, either in part or whole, and is not currently under consideration for publication elsewhere. The author(s) also warrant(s) that (a) the article, monograph or publication contains no libellous or unlawful statements, (b) it in no way infringes the rights of others (including the holders of copyright in material used within the work, (c) that permission has been obtained to reproduce any material or illustrations for which they do not hold copyright, and that (d) the author(s), as owners of the copyright, is (are) entitled to make the assignment set out in this agreement. The author(s) hereby indemnifies (indemnify) the Society against any claims for breach of the warranties given above.
6. The author(s) warrants (warrant) that the article, monograph or publication contains no plagiarised material and agrees (agree) that it may be checked for plagiarism and other ethical questions (including checks carried out by automated software packages). The Society reserved the right to withdraw or retract work for which, in its reasonable opinion, valid concerns exist over its originality or compliance with the Society's ethical policy.

Author(s) will receive six copies of a monograph, or publication and other copies may be purchased at a discount of 33 percent.

### **SUPPORTING NOTES**

1. The Society's policy is to acquire copyright from all contributors, because:
  - a. ownership of copyright helps to ensure maximum international protection against infringement;
  - b. requests for permission to reproduce published material in books, course packs or for library loan can be dealt with efficiently with regard to changes in international copyright law;
  - c. the demand for research literature to be delivered in machine-readable form, on-line or on CD-ROM or down-loaded on a file server, can be met efficiently, with proper safeguards for authors, editors and publisher.
2. There are opportunities to reach both individuals and institutions that do not subscribe to the Society's publications. This involves publishing on-line services or CD-ROM, or to deliver copies of individual articles. It also involves registering publications with the Copyright Licensing Agency in the UK and the Copyright Clearance Center in the USA, which offer licensing arrangements for photocopying. This produces income for the Society
